# Directions to New Jersey State House NJAEO Fall Meeting, Committee Room 11, State House Annex

### A. FROM THE SOUTH (SOUTHERN NJ)

Take I-295 NORTH to the Trenton-Shore Points, 29/129, I-195 Exit. Soon after you exit the road splits. Go left (Trenton 29/129) and remain in the right lane. Stay left as the road splits again and exit onto RTE. 29, TRENTON, CAPITOL COMPLEX. Take RTE. 29 NORTH, through the tunnel and traffic lights and take the MEMORIAL DRIVE EXIT. Next you will come to the light across from the WAR MEMORIAL (you are on Memorial Drive now); Bear right after the light and as you approach another light you will see two exit lanes. Take the right-most exit which will bring you into the drive around the New Jersey State Parking Lot #5b. As you drive around the parking lot, you will see the sign "CAPITOL COMPLEX PARKING." Turn right just past the sign, proceeding through another traffic light. Bear left and stop at the blue guard station to let them know you are attending the Election Officials Meeting. The guards will direct you to VISITOR PARKING as well as Committee Room #11, the meeting location.

IF YOU TAKE THE NJ TURNPIKE NORTH, get off at EXIT #7 and follow the signs to I-295 NORTH, then see instructions in "A".

#### B. FROM THE NORTH (NORTHERN NJ)

Take the NJ TURNPIKE SOUTH to EXIT #7A and take I-195 West to Trenton, then see instructions in "A" at Trenton-Shore Points, 29/129, I-195 Exit.

FROM THE NORTH (CENTRAL NJ)

TAKE RTE. 1 SOUTH to TRENTON. (RTE. 1 SOUTH will fork in Lawrenceville where you will go left choosing RTE. 1 SOUTH, TRENTON-PHILADELPHIA). Proceed on Route #1 until you see the sign "Warren Street Exit 1/2 mile". When you come to the exit, the sign will say "Capitol Complex, Last Exit Before Toll". After exiting, turn right onto Warren Street and turn left at the next light (Market Street). After going through the next light (William Trent Place) the road winds to the right as you follow the blue signs which say "State Capitol and Offices." [DO NOT EXIT ONTO ROUTE #29]. Make a left at the following intersection, and proceed in the right lane bearing to the left and make a right turn to Capitol Complex Parking at the next light. Go to the blue guard station and let them know you are attending the public hearing. The guards will direct you to VISITOR PARKING as well as Committee Room#11, the meeting location.

#### FROM THE NORTH (NORTHWESTERN NJ)

Take RTE. 80 East or RTE. 278 East to RTE. 287 South. Follow RTE. 287 South to the Easton Avenue Exit in New Brunswick. Follow Easton Avenue until it ends in a T intersection. Turn left at the T- intersection and look for signs for RTE. 18. Take RTE. 18 South to RTE. 1 South. At this point, follow directions for B.

## C. FROM THE EAST (EASTERN NJ)

Take I-195 West to where it connects to RTE. 29 going to Trenton. Follow directions in "A" at Trenton-Shore Points, 29/129, I-195 Exit.
